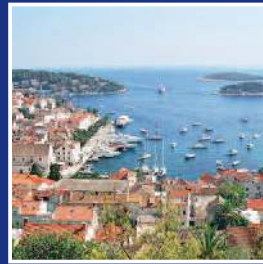

# Welcome to Britannia in The Croatia

## Britannia in the Croatia

For many years Britannia has been providing an excellent door to door shipping and removal service to Croatia, and can either transport your effects by shared load (groupage) or by sole use container load. Household and personal effects can be transported to Croatia in various ways; overland by road van, by sea containers or by air.

## Importing Personal Effects

Croatia is outside the EU and therefore goods are subject to Croatian Customs Regulations. Individuals and returning Croatian citizens wishing to import household goods need to be present for the customs clearance process. Used household goods may be imported duty free provided you have owned them for at least 6 months prior to arrival, and that the owner has resided abroad for at least 12 months prior to importation date.

## Documentation

Documentation required should be a copy of your passport, and detailed inventory list in English, and a completed Croatian customs declaration form. You will also need to provide a copy of your residence permit (for minimum of 6 months) and a work permit and/or agreement. Britannia will advise you of the full requirements prior to your move.

## Prohibitions and Restrictions

In general it is in your interest not to import the following items:

- Firearms & ammunition
- Inflammable goods & substances
- Plants & plant material
- Foodstuffs, perishables or otherwise
- Narcotics and dangerous goods
- Objectionable and indecent material
- Alcohol & Tobacco

## Transit Times

Transit times can vary subject to the method of transport chosen, size of your consignment and the final destination. Britannia will advise you once this information is established. Import customs clearance takes 1-2 days.

## Tracking Consignment

All groupage consignments will be bar coded before they are loaded into the shipping container. This will ensure that no items are left at origin and allow Britannia to check the status of your goods in transit.

## Motor Vehicles

Motor Vehicles can be imported, however vehicles are subject to special regulations and import duties and taxes. The vehicle must have been owned for a minimum of 6 months before importing.
